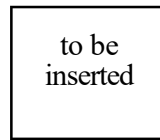

Dear Parents/Guardians,

The school has successfully completed its 43 years of excellence in education since its inception. As the school prepares itself for the new academic session 2024-25, we are optimistic of an accelerated growth in education and activities.

- ❖ There was active participation of students in all activities, competitions and events organized by the school, DIOS, RMSA and CBSE. Many students won medals, mementos and certificates too. School actively participated in Hubs of learning from CBSE.
- ❖ We have reached out to the diverse and remote people through our Facebook, YouTube and Instagram posts and uploads. This propagates our students' talent to a wider platform and help them unleash their potential too.

We proudly announce the inauguration of our fourth branch on 29th March 2024 at Mohanlal Ganj. As we gear up to frame yet another success story in the upcoming session 2024-25, we share some of the distinguishable features of our institution.

1. **The Management, as a very special case, has decided to waive admission fee to the girl students, who seek admission, as new entrants, in classes Pre Nursery to IX and XI during the period from April 1, 2024 to April 30, 2024.**
2. The Central Board of Secondary Education has granted affiliation to our schools upto class XII in Science, Commerce and Humanities. We also offer vocational courses like Financial Market Management, Information Technology, Yoga, Artificial Intelligence and elective subjects like Music & Painting.
3. The School is equipped with state-of-art technology to enforce the child's growth in all the spheres of life.
4. The School Portal is now available on Smartphone as an application for easy access to syllabus and performance updates of children.
5. We, at Red Rose Group of Schools work for the all-round development of the students. In keeping this practice, we conduct English and Hindi Elocution, debates and class presentations.
6. The school provides all requisite facilities such as : Well-stocked Library, Science Laboratories, Computer Lab, Math Lab, English Lab, A/V Classes, Sports & Music room.
7. Red Rose Sports Academy runs under the aegis of Red Rose Senior Secondary School. Children are given exposure to various indoor & outdoor sports too.
8. Selected Girls of the school are undergoing NCC training too. This instills camaraderie, discipline, moral values and ideals of selfless service in them.
9. For security purpose, the school has CCTVs installed in the premises and vicinity that function 24x7.
10. **Remission of one-month fee is granted if the fee for the entire session is deposited in lumpsum, just at the commencement of the session. Thus, fee for eleven months only will be charged. This remission will also apply to any such case of Conveyance Fee.**

11. Fee can be paid online through school portal. Fee for a month must be deposited by 10th of each month, otherwise a fine of Rs.20/- per day will be charged. Fee will only be accepted online after 20th of every month. If the fee is not deposited for two months in succession, the student's name is liable to be struck off the rolls and admission charges will be applied.
12. **A Planner** detailing the activities to be conducted by the school during the whole academic session is provided to each student of the school. This is to enable guardians to prepare their child for exams, competitions and activities, well in advance, according to the date and activities mentioned in the Planner.
13. **Parent-Teacher meeting** will be conducted as mentioned in the planner. Your presence on the day is essential to know the progress of your child. However in case of urgency, parents can meet the Principal on after seeking appointment.
14. Arrangement of extra-classes, free of any charge, exists specially for classes IX to XII students in order to bring them upto the desired level. Private tuition by school teachers is strictly prohibited. Thus, no parent or student should approach any teacher for tuition. In case of special cases, it can be conducted in the school itself on permission by the Principal.
15. We prepare our students not only for academic excellence but we also provide them a wider platform by giving them opportunities to participate in National Level Competitions like Unified Council - NSTSE, Cyber Olympiad etc.
16. Periodic and Half yearly assessments are held to provide regularity in studies. Since the marks obtained in these assessments are added to the marks obtained in the Annual Examination for assessing the rank, it is necessary for the students to take these assessments.
17. Please note that smoking and chewing of tobacco in and around the school campus is strictly prohibited. Parents must refrain from such activities. Parents are expected to be formally dressed when they visit the school.
18. Ours is No - Polythene Zone. Staff, Parents and students are not allowed to bring plastic polybags to school.
19. In the beginning of the new session, the attendance of your ward continuously for 3 working days is necessary. In case of absence during first three days, the name shall be struck off the rolls and the ward will be liable of re-admission.
20. Guardians are requested to ensure regularity of their wards in attending the school from the beginning of the session. The students of classes X & XII shall be allowed to appear in the Board Examination provided their attendance in the academic session is 75% or more.
21. Students must be regular and punctual in attending the school and in completing their assignment daily.
22. Late arrivals, absence without leave, negligence in doing class and home work, paying no attention to studies in the class are seriously viewed as these are tantamount to misconduct and dereliction of duty. Strict action will be taken against the habitual defaulters. **Late comers will not be allowed to enter the school and will be sent back home.**
23. **Guardians are requested to ensure that their wards attend school in the prescribed school uniform.**
24. No child is allowed to drive any motor vehicle / bike to school. Any such case shall be strictly dealt with.
25. Please ensure that your ward does not bring Mobile Phones or any other gadget to school as its use in the school campus is prohibited. If found, the mobile will be confiscated.
